Mandatory Philippine National Standards (PNS) for Self-Ballasted LED Lamps for General Lighting Services (5 page(s), in English)

6. Description of content: Under this Department Administrative Order, all manufacturers, distributors, importers, and retailers of Self-ballasted LED Lamps shall comply with the requirements of the Philippine National Standards.

The scope of implementation shall cover Self-ballasted LED-Lamps for General Lighting Services by Voltage > 50 V - Safety Requirements covered by PNS IEC 62560:2012, intended for domestic and similar general lighting purposes, having:

- a rated wattage up to 30 W
- a rated voltage > 50 V up to 250 V
- E14 and E27 caps
- **7. Objective and rationale, including the nature of urgent problems where applicable:** Mandatory implementation of Philippine National Standards for Self-ballasted LED Lamps for the safety of the consumers.
