Description of content:** Draft technical regulation approving technical quality requirements for reusable packaging, portable tanks and intermediate containers IBC, used in the land transport for retail market transportation of hazardous automotive fuels, manufactured, imported and distributed in the national territory, according to the National Land Transportation Agency (Agência Nacional de Transportes Terrestres ANTT) Resolution 5.232/2016, for conformity assessment through certification, observing the deadline established in art. 3 of this Ordinance.

Technical Regulation for reusable packaging used in the retail market for automotive fuels, inserted in Annex I

Conformity Assessment Requirements - for Containers, Portable Tanks and Intermediate Containers for Bulk - IBC Used in Ground Transportation of Hazardous Products, included in Annex II of this Ordinance
